# MEMBERSHIP INFORMATION

## PRIMARY PRODUCER MEMBERSHIP

You are eligible if your company/business/employer has over 50 head of cattle, 30 cents per head branded in the company with a maximum of \$15,000 ex GST per annum and a minimum of \$1,500 ex GST.

- A business/company is qualified for Primary Producer Membership if s/he is involved in Agricultural primary production and pays at least the minimum full membership fee of \$1,500 ex GST

### BENEFITS

- Representation on issues that are important specifically to the Northern Beef Industry at a Local, State and Federal Government level
- 10% membership discount to KPCA hosted events and courses
- Access to bureaucratic process support (e.g. advocacy and professional correspondence)
- Voting rights at the AGM
- Two representatives are allowed per business/company at KPCA events at the discounted rate
- One vote allowed per business on key decisions and one place on the Executive if voted in
- On-station requested and industry relevant research, extension, adoption and monitoring
- Preference for on-station research projects and input into what is relevant for this area
- Discounts with key industry partners and service providers
- Ability to shape the direction of the organisation and industry (both informally and through an annual 'have your say' survey)
- Opportunity to participate in international industry tours

**Please note:** No manager of a property shall be eligible for a Primary Producer Membership unless his/her principal is also a Primary Producer Member.

## STAKEHOLDER MEMBERSHIP - \$3,000 PER ANNUM

- A business/company is qualified for Stakeholder Membership if s/he/they is/are involved in an organisation servicing primary producers

### BENEFITS

- One representative per business/company to vote at our AGM
- Opportunity for one of two Executive roles if voted in
- Promotion of your business logo and link on our website homepage
- 100 word profile of your business on membership section of our website
- Opportunity to contribute one 200-300 word article in Fortnightly Five newsletter (maximum two articles per year) on relevant industry topics
- Opportunity for promotional activities (e.g. regular mentions on social media and in Fortnightly Five newsletter – members to provide the content)

## ASSOCIATE MEMBERSHIP - \$500 PER ANNUM

- A person is qualified for Associate Membership if s/he is not eligible for Primary Producer Membership
- A membership for people who want to support the industry and stay informed with what is relevant to our region and sector
- An Associate Member must not own more than 50 head of cattle
- Logo in the membership section of our website

## YOUTH MEMBERSHIP - \$100 PER ANNUM

- A person is qualified for Youth Membership if s/he is 25 years of age or younger and working in the agriculture industry
- Opportunity to partake in the KPCA Youth Leadership Program (Must be working on a station)
- Opportunity to connect with and learn from other young people involved in the agriculture industry
- Ability to shape the direction of the organisation and industry (e.g. via motions to the Executive)

### NOTE TO APPLICANTS

- If your application is accepted, your name and address, as provided above, **must** be recorded in a register of members and be made available to other members, upon request, under section 27 of the Associations Incorporation Act. If the obligations under the *Associations Incorporation Act* are not complied with the Association can be wound up

- If your application is accepted, you are entitled to inspect and make a copy of the register of members under section 27 of the Associations Incorporation Act.
- If your application is accepted, you are entitled to inspect and make a copy of the rules (constitution) of the association under section 28 of the Associations Incorporation Act.

**If your application for membership is rejected by the Committee:** You may give notice of your intention to appeal within 14 days of being advised of the rejection (rule 5(4)). The Association in a general meeting, no later than the next annual general meeting, must confirm or set aside the decision of the Committee rejecting your application, after giving you a reasonable opportunity to be heard or to make written representations to the general meeting (rule 5(5)).
